REGULAR COUNCIL MEETING CITY OF CROSSLAKE MONDAY, OCTOBER 8, 2001 7:00 P.M. – CITY HALL

The Council for the City of Crosslake met in the Council Chambers of City Hall on Monday, October 8, 2001. The following Councilmembers were present: Mayor Darrell Swanson, Sandy Eliason, Charles (Chuck) Miller, Irene Schultz and Dean Swanson. Also present was City Administrator Thomas (Tom) Swenson, City Attorney Paul Sandelin, City Engineer Dave Reese, Community Development Director Paul Larson, Police Chief Bob Hartman, Park and Recreation Director Jon Henke, Public Works Director Ted Strand, General Manager Dennis Leaser, Clerk/Treasurer Darlene Roach and Lake Country Echo Reporter Betty Ryan. There were eight individuals in the audience.

- A. CALL TO ORDER Mayor Swanson called the Regular Meeting to order at 7:00 P.M.
- B. CRITICAL ISSUES Jeanne Horning of 27127 Blacksmith Place addressed the Council and expressed concern about bow hunting that is taking place in Old Log Landing. She proposes that the City restrict bow hunting within the City limits. She stated that children on bikes, animals and etc. could be unintentional targets of this activity. She stated that while she is not against bow hunting she does not feel that it should be done in residential areas. Mrs. Horning agreed that the deer population is growing and may need to be thinned out but not by way of bow hunting in residential areas. Councilmember Miller stated that bow hunters are also hunting on City property and felt the City has a liability issue. Local DNR warden Cary Schoutz addressed the Council. He stated that the DNR has received more complaints on the deer population then they have on bow hunters. was some discussion regarding adopting a feeding ordinance which would prevent property owners from feeding deer which results in the overpopulation of deer in residential areas. It was the consensus of the Council that the Safety Committee meet to discuss what options are available to the City and to come back to the Council with a recommendation. Butch Doerfler addressed the Council and stated that he felt for the people that live close to where the bow hunters are hunting, but requested that the Safety Committee not have blinders on and impose something for all areas within the City limits.

Councilmember Sandy Eliason stated that the League of Women Voters is holding a School Board Candidate's Meeting on Tuesday, October 23rd at 7:00 P.M. at the Pequot Lakes School Gathering Room. The meeting will be broadcast on Channel 12 on October 24th at noon and 6:00 P.M.

- 1. ECONOMIC DEVELOPMENT AUTHORITY The minutes of the September 5, 2001 meeting were included for Council information.
- CHARTER SCHOOL Councilmember Irene Schultz reported that the Pequot Lakes School District is handling transportation for the Charter School for most students. Students living in Fifty Lakes and Pine River need to be brought to a designated pick up location within the Pequot

- Lakes School District. A Parent Teacher Association (PTA) has been formed and anyone interested in joining can do so for a \$5 fee. The Charter School is looking for volunteers to help at the school. Interested persons can call Kelly Stone at 692-4454.
- 3. LIBRARY COMMITTEE Alden Hardwick stated that a letter was received from Marian Ridge, Director of the Kitchigami Regional Library System offering to submit grants for "opening day" books for the proposed Crosslake library. The Committee is appreciative of this favorable support from the Library System. Seven grant requests are still outstanding with no responses having been received from the organizations. When representatives from the Department of Children, Families & Learning addressed the Council they recommended that the Committee contact the Department of Finance for funding and the Committee is preparing to do this.
- 4. UTILITIES COMMISSION General Manager Dennis Leaser reported that the building expansion is in its final stages with only the flooring, heating and cooling units needing to be installed. Onvov's annual meeting, which was held in St. Cloud, was attended by Dennis. Onvoy is launching a new program which will increase commissions and volume pricing for Crosslake Communications. Crosslake Communications is now offering 711 for the hearing impaired. Users dial 711 and are directed automatically to a TYY operator. A 511 program is also being offered. This service is an online menu driven weather and road condition reporting system. Crosslake Digital TV has been launched and orders are backing up. Cable boxes have been limited to 2 per household in order to keep up with the demand. Debby Floerchinger celebrated her nine year anniversary on September 21st. The Five Year Strategic Planning Session has been scheduled for October 17th from 9:00 A.M. to 3:00 P.M. at the Community Center. Del Gilsrud has resigned from the Utilities Commission and approval was requested to appoint Hank Duitsman to fill the vacancy. - 6. PARK AND RECREATION Park and Recreation Director Jon Henke reported on the progress being made in regards to purchasing the

approximately 79 acres of land adjacent to the Community Center. Property owner Eric Johnson has signed a purchase agreement. Approval was requested to authorize the Mayor and City Administrator signing the purchase agreement on behalf of the City. City Attorney Paul Sandelin stated that the City should be in receipt of the survey being prepared by Landecker & Associates prior to signing the purchase agreement. personal items situated on the property needs to be removed. - Jacob's Holding Metes and Bounds Subdivision Park Dedication
 At a meeting held on September 21, 2001, the Planning and Zoning Commission approved a metes and bounds subdivision

for Jacob Holdings of Crosslake LLC. The land area of the subject property is 5 acres. The City requires dedication of parkland or cash in lieu of land for all land subdivisions in an amount equal to 10% of the current assessed value of the land. According to the Crow Wing County Auditor, the estimated market value of the subject property is \$552,300. Ten percent of this amount is \$55,230. The applicant is requesting a reduction in the requested fee since Tract A is already developed and has a house situated on the property. Ten percent of the market value of Tract B and Tract C would be \$22,840. MOTION 010R-42-01 WAS MADE BY IRENE SCHULTZ AND SECONDED BY **ELIASON** TO APPROVE RECOMMENDATION OF THE PLANNING AND ZONING **AND** PARK AND RECREATION COMMISSION DEPARTMENT THAT CASH IN LIEU OF LAND BE COLLECTED FOR PARK DEDICATION IN THE AMOUNT OF \$22,840 FOR TRACT B AND TRACT C FOR METES AND BOUNDS SUBDIVISION 01-08. Councilmember Swanson inquired whether the City has had a situation previously where one of the tracts is omitted from the calculation when paying park dedication fees. Community Development Director Paul Larson stated that the City has not previously omitted a parcel on a metes and bounds subdivision. Councilmember Miller stated that he could see deducting the value of the home but not the land. Discussion ensued regarding whether the market value of Tract A should be excluded from park dedication Ted Pederson, representing the applicant, addressed the He used an example of a neighbor purchasing an Council. additional piece of property from an adjacent neighbor who has developed the property and has a home situated on a portion of the property. In this example, the City would not require park dedication fees on the property owned by the neighbor who was selling a portion to his neighbor. City Attorney Paul Sandelin stated that in order to use different rules for metes and bounds subdivisions, the Ordinance would need to be amended. City Attorney Sandelin stated that the Council could table the issue upon consent of the applicant. Ted Pederson, acting on behalf of the applicant, agreed to an extension in order to allow time to amend the Ordinance. MOTION FAILED.

The land area of the subject property is 2.9 acres. Park Dedication requires the developer of a subdivision to dedicate 10% of his usable land to the public for park purposes or, at the option of the City Council, pay the City an amount equal to 10% of the current assessed value of the land prior to development. According to the Crow Wing County Auditor the 2001 estimated market value of the subject property is \$6000. Ten percent of this estimated market value is \$600. Since the minimum park dedication fee per lot is \$500, staff recommends that a total park dedication fee of \$1000 be paid for this land subdivision. Park and Recreation Director Jon Henke concurs that cash in lieu of land be collected for park dedication. MOTION CARRIED WITH ALL AYES.
- Zoning Map Amendment 01-12, (0) Open District to (R-3) Medium Density Residential - Jon Otterlei requested a rezoning of two islands located in the southern portion of Rush Lake from Open (O) zoning district to Medium-Density Residential (R-3). The Planning and Zoning Commission tabled the item at their August 17, 2001 meeting to the September 21, 2001 meeting for the submittal of additional information on possible Native American artifacts onsite. The Planning and Zoning Staff contacted the State Historical Preservation Office (SHPO) for guidance on the standards and procedure for requesting a Phase I Archeological Survey. The State Office stated that a Phase I survey is not required for this type of rezoning request, however, they would recommend that one is done whenever concern for historic sites are an issue. SHPO also pointed out that such a survey would be entirely up to the City. On September 21, 2001 the Planning and Zoning Commission recommended approval of Ordinance Map Amendment 01-12 to the City Council as long as a Phase I Archeology Survey was conducted as part of the application. Staff visited with the archeologist conducting the archeological study on Tuesday, October 2, 2001. The findings

- were limited to small stone shards from tool-making activity, pottery fragments and other traces of early inhabitant activity. A complete report was provided to the Council during the meeting. Mayor Swanson commented that he felt it would be in the common good of the community to preserve the open space. He further stated that the islands are located in an area where the DNR has preserved other land. Councilmember Miller stated that emergency services from the fire department or ambulance personnel would be non-existent to this area. Councilmember Eliason felt the rezoning would create additional erosion problems. See Motion on Page 14 of minutes.
- Zoning Map Amendment 01-14, R-4 Urban Residential to LC, Limited Commercial, Evangelical Free Church - The applicant is requesting a zoning change in order to use the property as a commercial use. This property was zoned commercial in 1971 and remained so until May 10, 1999 when it was rezoned to R-4. Urban Residential. Properties in the immediate vicinity of the subject property are used for residential and light commercial purposes so the zoning change would not constitute spot zoning. The Planning and Zoning Commission reviewed this change and recommends approval by the City Council. MOTION CARRIED WITH ALL AYES.
- h. E-911 Address & Sign Coordination with Crow Wing County The process for acquiring property addresses and installing signs is currently somewhat cumbersome with the involvement of the Planning and Zoning Staff, Public Works Staff and staff from the Crow Wing County Surveyor's Office. It was the

recommendation of City staff, that the process be taken over in its entirety by Crow Wing County. CROSSLAKE COMMUNITY CENTER POLICIES, FEE'S & RESERVATION FORM



The mission of the Crosslake Parks and Recreation Department is to provide recreational services that positively impact the health of our citizens, the environment, the economy and the quality of life in our community.

Community Center Usage Policies

Updated 9/01

Welcome to the Crosslake Parks and Recreation Department and the Crosslake Community Center. This center provides a central gathering place for the Community to participate in recreational and leisure-time pursuits. The Crosslake Community Center is available to the public for meetings, parties, and special events. Certain policies are needed to insure the proper use and control of the facility so that all people may equally enjoy it.

- A. The Crosslake community Center may be reserved in hour blocks. The hours may vary with the seasons. Please check with the Community Center regarding the exact hours of operation. An additional fee of \$20/hour is charged for events beginning or ending after the hours of operation.
- B. A cleaning/damage deposit (\$50.00/meeting rooms, \$100.00/gym) is required by groups utilizing the facility. If the facility is left clean and in good condition, the deposit will be returned. If not, the group will be charged the actual cost of cleaning and/or forfeit their deposit. Deposits must be made with a separate check and can be picked up on the Tuesday following the event.
- C. Any request for special room arrangements will be charged a fee of \$20.00 per hour plus the regular rental fee.
- D. The Community Center or meeting rooms in the Community Center may not be reserved for more than 4 meetings per month by the same organization for the same basic purpose. Any organization wishing to reserve the center for set dates running throughout the calendar year must place in writing such requests (listing dates, times, group name, function of meeting, approximate attendance and the person responsible). This request must be sent to the Parks and Recreation Department on or before December 1st for the coming calendar year.
- E. Every group utilizing the facility must have competent adult leadership (and be at least 21 years of age). The individual signing the reservation form is considered responsible for the group's conduct while using the facility. Any special supervision needed shall be supplied by the applicant as requested by the City or the Parks and Recreation Department. However, the City and Parks and Recreation office reserves the right to assign a City supervisor and/or custodian when appropriate, the cost of which will be charged to the group using the facility.

Indemnification/Hold Harmless:

To assure the City is indemnified and protected from liability claims that may arise out of activities sponsored by a third party, indemnification/hold harmless statements and or insurance certificates may be required, and if so, must be received from sponsors 30 days prior to the scheduled event.

Indemnification and insurance is required of reservation groups if:

- *Groups will have special apparatus or equipment that presents an unusual risk.
- *Groups are commercial endeavors for the sole benefit of the sponsor.
- *Groups event is conducted by a third party sponsor and open for general public participation.

CROSSLAKE COMMUNITY CENTER GYM/ROOM RENTAL POLICY 5/22/00 (Policy manual) Revised again 9/17/01

NOTE: WEIGHT ROOM WILL REMAIN OPEN DURING THE NORMAL CENTER HOURS.

- 1. Requests for the use of the CCC Gymnasium must be made at least 14 days in advance. Advanced reservations are encouraged for the meeting rooms but not required. All reservation forms, rental payment and deposits must be made at the time of the reservation.
- 2. Cancellations for the gym/meeting rooms must be made 7 days in advance of the scheduled date or the rental fee will be forfeited.
- 3. Cleaning/Damage deposit shall be in the amount of \$100.00 for all groups renting the gymnasium. Cleaning/Damage deposit for the meeting rooms will be in the amount \$50.00.
- 4. Notices will be posted in the Community Center 7 days in advance of any function reserving the gymnasium.
- 5. A clean up list will be provided for the party who has made the reservation. This list will be completed by the user and turned into the Community Center office before the group leaves the building. Groups that fail to clean up properly will lose their deposit. Groups that follow the rental agreement can pick up their deposit the Tuesday following the event or if the damage deposit is used the balance, if any, will be mailed out to the person who's name appears on the reservation form.
- 6. Groups that go past the reserved times will have the hourly charge taken out of their deposit. The charge will be the original per hour cost + \$20.00 for each additional hour of use.
- 7. The presence of alcoholic beverages is prohibited.
- 8. Children using the gymnasium/meeting rooms must have adult supervision at all times.
- 9. Set up and take down will be the responsibility of the reservation group unless it is requested by the staff of the CCC. Failure to put away all equipment will result in the loss of the damage/cleaning deposit. If a group chooses to have the Community Center staff provide set up/take down, and the service is available for the reservation time, the groups will be charged from the following criteria.

Set-up/Take Down Fee: This service will only be available if staffing permits. The minimum charge for set up of equipment will be \$5.00. Up to 6 banquet tables will be set up for this fee. A fee of \$3.00 per table will be charged for set up and take down of tables over the amount of six. The \$5.00 minimum fee for set up/take down does apply for card tables. 
