#### COUNCIL PROCEEDINGS CROSSLAKE, MINNESOTA REGULAR SESSION - May 13. 1985

The City Council of Crosslake, Minnesota met in a regular session on May 13, 1985 in the Council Room of the Municipal Building. The following members were present: Mayor August Mezzenga, Councilmen Robert Allen, Tom Douglas, Orval Nelson and Oliver Yates. There were approximately 20 people from the community present.

- I. Mayor Mezzenga called the meeting to order at 7:30 p.m.
- II. CONSENT CALENDAR Minutes of the April 8, 1985 meeting were corrected by changing Motion No. 4R-13-85 to read that Councilman Nelson made the motion to adjourn, not Mayor Mezzenga; minutes of April 15, 1985 special session; Clerk/-Treasurers financial report for April and the Telephone Co. financial report for April.

MOTION NO. 5R-01-85 WAS MADE BY COUNCILMAN NELSON TO APPROVE ALL ITEMS ON THE CONSENT CALENDAR WITH THE CORRECTION OF THE WORDING IN THE MOTION TO ADJOURN THE APRIL 8 MEETING. MOTION WAS SECONDED BY COUNCILMAN DOUGLAS AND PASSED UNANIMOUSLY.

III. A. Duane A. Blanck, Crow Wing County Highway Engineer regarding Project SAP 18-637-01. (Highway 36 to County Road #3 by way of new bridge).

Mr. Blanck spoke briefly on the construction now taking place on County Road No. 6 on the North side of Crosslake. He said they would keep the highway open for businesses and emergency use but people could expect delays from time to time.

Mr. Blanck said the bridge on the South side of Crosslake by the of Federal Dam will probably be started after Labor Day this year. It will look just like the bridge over the Daggett Channel but will be slightly shorter. It will have 24 feet of driving surface connecting the bridge and 8 foot shoulders. They would hope to have it open by the middle of Spring 1986 or at least by July 4, 1986. He said we do not have the traffic here to force any deadlines or bonuses for meeting deadlines but they will do their best because they realize it is hard on business establishments. It seems we have had construction 3 years out of 4 but we are getting it done for few tax payers dollars at the local level and we will have good roads when the construction is all done.

There was a question raised from the audience regarding the repaving of County Road No. 16 west of West Shore Drive. Mr. Blanck said possibly in 1987 or 1988 but there is a moratorium at the County level on road construction and only patching is being done at the present time.

There was also a question from the floor regarding the possibility of the City getting some road work done at a savings now since the trucks and equipment are working and hauling in the area. Mr. Blanck said that would be a possibility.

Mr. Blanck proposed two resolutions for Council action. MOTION NO. 5R-02-85 WAS MADE BY COUNCILMAN NELSON AND SECONDED BY COUNCILMAN DOUGLAS, TO REQUIRE THAT PARKING OF ALL VEHICLES WITHIN THE CORPORATE LIMITS ON HIGHWAY NO. 3 BE PARALLEL WITH THE CURB IN ACCORDANCE WITH THE STATE AID STANDARDS. MOTION PASSED UNANIMOUSLY.

NOTION NO. 5R-03-85 WAS MADE BY COUNCILMAN ALLEN, SECONDED BY COUNCILMAN YATES TO APPROVE ALL SAID PLANS FOR PROJECT NUMBERS S.A.P. 18-636-06 (CSAH-36), S.A.P. 18-637-01 )CSAH-37) AND S.A.P. 18-603-10 (CSAH-3). MOTION PASSED UNANIMOUSLY.

Mayor Mezzenga thanked Mr. Blanck for his presentation.

- III. B. Don Coulter, Surveyor Ox Lake Landing Preliminary Plat
  (Re-approval necessary due to time delay.)

  Mr. Coulter said the preliminary plat was approved by the City
  Council in December of 1981 but due to a Torrens proceeding which
  took 3 years he wanted reapproval. All lots and roads meet requirements of the City. Mr. Coulter said he realized there is a moretorium on City roads until July but he still needed approval on the
  Plat. MOTION NO. 5R-04-85 WAS MADE BY COUNCILMAN ALLEN, SECONDED
  BY COUNCILMAN NELSON, TO: APPROVE THE OX LAKE PRELIMINARY PLAT.
  MOTION PASSED UNANIMOUSLY.
- MOTION NO. 5R-05-85 WAS MADE BY COUNCILMAN NELSON TO APPROVE A PULL-TAB LICENSE FOR THE LION'S CLUB CONTINGENT UPON A RULING BY STEVE RATHKE'S OFFICE AND THE STATE GAMBLING BOARD THAT IT CAN BE LICENSED AT THE LOCAL LEVEL. MOTION WAS SECONDED BY COUNCILMAN DOUGLAS AND PASSED UNANIMOUSLY.
- III. D. Approval of Annual Audit for 1984 from the office of Donald Engen, C.P.A.
- Mr. Engen went through the Audit for the benefit of the Council. He also had two suggestions. One was to have someone go through the complete insurance package for the City and two was that the City has some Revenue Sharing dollars that must be spent before October 1985 or we will lose them. MOTION NO. 5R-05-85 WAS MADE BY COUNCILMAN NELSON, SECONDED BY COUNCILMAN ALLEN, TO APPROVE THE 1984 ANNUAL AUDIT AS PREPARED. MOTION PASSED UNANIMOUSLY.
- IV. A. Sunday liquor license for Andy's Cafe
  MOTION NO. 5R-07-85 WAS MADE BY COUNCILMAN NELSON TO APPROVE SUNDAY
  LIQUOR LICENSING FOR THE REMAINDER OF THIS LICENSING PERIOD (JUNE 30,
  1985). MOTION WAS SECONDED BY COUNCILMAN DOUGLAS AND PASSED
  UNANIMOUSLY.

#### RESOLUTION

WHEREAS, the County of Crow Wing has submitted to the Commissoner of Transportation the plans and specifications for the improvement of County State Aid Highway No.3 in the City of Crosslake.

WHEREAS, state-aid funds will be expended on the improvement of this highway, and

Mayor Mezzenga stated that there would be an informational meeting presented by R.E.A. on dual fuel, off-peak heating and fuel assistance at the Community Center on May 16 at 7 p.m.

An Ad-Hoc Committee to check available methods of financing roads and remodeling was appointed by Mayor Mezzenga. The appointees are Orval Nelson, Don Engen, Tony Mayer, Walt Kocon, Judy Cotton and August Mezzenga.

Mayor Mezzenga stated the Commissions were advisory groups and should not be involved in signing purchase orders for payment, etc. He said the Council has that responsibility. In order to relieve the situation he appointed Council liaison as follows: Roads, Councilman Yates; Parks and Cemetery, Councilman Douglas; Planning and Zoning, Councilman Allen; Personnel, Councilman Nelson; and Public Safety and Telephone, Mayor Mezzenga.

Mayor Mezzenga again reiterated that the Ordinance on Commissions says the Mayor makes all appointments. He would like two or three names for vacancies and will appoint from those names as he sees fit or will ask for more names.

Councilman Douglas shared a copy of a letter he had received from a lady who wanted to place a monument on her Mother's grave. It

was decided we would go along with the Rules and Regulations of the Pinewood Cemetery as printed in 1972. Councilman Douglas said he would be writing a letter to the local clergy as well as the funeral homes and include a copy of the Rules. He also said a copy of the Rules would be sent along with the deeds for any lots purchased.

#### VI. C. Funding and Future Development Nothing

Bill Heisserer, Chairman of the Park Commission reported that the sprinkler system is almost completed and that planting of flowers shrubs and trees has begun. He said the Park Board is checking into some playground equipment and will probably contact the Lion's Club for financial assistance.

Mr. Heisserer said there will only be need for one rink by the Hockey association next year and that they hoped to keep the other rink available for open skating.

#### ORDINANCE NO. 7, THIRD SERIES

AN ORDINANCE OF THE CITY OF CROSSLAKE, MINNESOTA, AMENDING CITY CODE CHAPTER 8 ENTITLED "LAND USE REGULATIONS (ZONING)" BY CHANGING TITLE OF PERSON AUTHORIZED TO DO CERTAIN REQUIREMENTS FOR VARIANCE PERMITS; AND, BY ADOPTING BY REFERENCE, CITY CODE CHAPTER 1 AND SECTION 8.99 WHICH, AMONG OTHER THINGS, CONTAIN PENALTY PROVISIONS.

THE CITY COUNCIL FOR THE CITY OF CROSSLAKE ORDAINS:

Section 1. Crosslake City Code Sec. 8.70 entitled "Administration" is hereby amended by changing Subparagraph B of Subd. 3 entitled "Variances", to read:

Subd. 3. Variances.

- B. Procedure for Variation.
- 1. Requests for a variance or appeal shall be filed with the Planning and Zoning Coordinator on an official application form. Such application shall be accompanied by a fee as established by Council resolution. Such application shall also be accompanied by detailed written and graphic materials necessary for the explanation of the request.
- 2. Upon receiving said application, the Planning and Zoning Coordinator shall refer the application, along with all related information to the Planning Commission for consideration.
- 3. The Planning Commission shall consider the variance at its next regular meeting unless the filing date falls within fifteen (15) days of said meeting in which case the request should be placed on the agenda and considered at the regular meeting following.
- 4. When an application for a variance permit is filed with the Planning and Zoning Coordinator, he or she shall then cause to be published in the legal newspaper for the City, a notice of the hearing for such application; such application shall be not more than two (2) weeks nor less than ten (10) days before the hearing time set by the Zoning Coordinator for a meeting of and scheduled by the Board of Adjustment. The published notice, which may be combined for several variance applications shall state the time, date, and place of the hearing, the legal description of the premises covered by the application, and the purpose for which the application was made. The Planning and Zoning Coordinator shall also, by mail, send notice of hearing to all owners of property within three hundred fifty (350) feet of the parcel included in the request.
  - 5. The applicant or a representative thereof shall appear before the Planning Commission in order to answer questions concerning the proposed variance request.

- 6. The Planning Commission shall have the authority to request additional information from the applicant concerning the variance or to retain expert testimony with the consent and at the expense of the applicant concerning said variance where said information is declared necessary to insure preservation of health, safety and general welfare.
- 7. The Planning Commission shall make a finding of fact on which to base their decision relating to the request as it deems necessary to carry out the intent and purpose of this Chapter.
- Section 2. Crosslake City Code Chapter 1 entitled "General Frovisions and Definitions Applicable to the Entire City Code Including Penalty for Violation" and Sec. 8.99 entitled "Violation a Misdemeanor" are hereby adopted in their entirety, by reference, as though repeated verbatim herein.
- Section 3. Effective Date. This ordinance shall be in full force and effect from and after its execution and publication.

THE CITY COUNCIL FOR THE CITY OF CROSSLAKE ORDAINS:

- Section 1. Crosslake City Code Sec. 8.70 entitled "Administration" is hereby amended by changing Subd. 3, to read:
  - Subd. 3. Variances. A variance from the literal provisions of this Chapter may be granted by the Planning Commission, serving as the Board of Adjustment, in instances where the strict enforcement of such provisions would cause undue hardship because of circumstances unique to the individual property under consideration only when it is demonstrated that such action will be in keeping with the spirit and intent of this Chapter.
  - A. The term "undue hardship" as used in this Subdivision means the following:
  - 1. The property in question cannot be put to a reasonable use if used under conditions allowed by this Chapter.
  - 2. The Plight of the owner of the property in question is due to circumstances unique to his property and not created by him.
  - 3. If the variance is granted, it will not alter the essential character of the locality.
  - 4. The term also includes, but is not limited to, inadequate access to direct sunlight for solar energy systems.
  - B. Economic considerations alone will not constitute and undue hardship if reasonable use for the property exists under the terms of this Chapter.
  - C. Variances shall be granted for earth sheltered construction as defined by statute, when in harmony with this Chapter.
    - D. A variance may not be granted for any use that is not permitted or conditional under this Chapter for property in the district where the affected land is located.

- E. A variance may be granted for the temporary use of a one-family dwelling as a two-family dwelling.
- F. A variance may be granted which imposes conditions to insure compliance and to protect adjacent properties.
- G. No variance permitting the erection or alteration of a building shall be valid for a period longer than six (6) months unless construction is actually begun within that period, and is thereafter diligently punsued to completion.
- Section 2. Crosslake City Code Sec. 8.35 entitled "(MH) Manufactured Home Park District" is hereby amended by changing Subd. 8, Subparagraph A, Item 9, to read:
  - 9. "State Code" The Manufactured Homes Building Code, presently Minnesota Statutes, SS 327.31-327.35.
- Section 3. Crosslake City Code Sec. 8.40 entitled "(C-1) Commercial District" is hereby amended by adding a Subdivision to read:
  - Subd. 7. Any structure designed to be used as a dwelling shall be palced on a foundation constructed of masonry, concrete or treated wood.
- Section 4. Crosslake City Code Chapter 8 is hereby amended by adding a Section to read:
  - SEC. 8.71 FILING OF DOCUMENTS. A certified copy of every amendment, resolution, map, regulation, variance and conditional use permit shall be filed for record with the County Recorder or Registrar of Titles. Legal descriptions shall be included.
- Section 5. Crosslake City Code Sec. 8.70 entitled "Administration" is hereby amended by repealing Item 15 of Subparagraph E, Of Subd. 4, entitled "Conditional Uses" as to requirement of a zoning permit.
- Section 6. Crosslake City Code Chapter 1 entitled "General Provisions and Definitions Applicable to the Entire City Code Including Penalty for Violation" and Sec. 8.99 entitled "Violation a Misdemeanor" are hereby adopted in their entirety, by reference, as though h repeated verbatim herein.
- Section 7. Effective Date. This ordinance shall be in full force and effect from and after its execution and publication.
